

Terms and Conditions of Use

Welcome to www.finametrica.com ("Website"). This Website is owned and operated by FinaMetrica Pty Ltd (referred to as "FinaMetrica", "we", "us" or "our"), a company registered in Australia, ACN 081 638 271 whose registered office is at Suite 1703, Level 17, 227 Elizabeth Street Sydney, NSW 2000, Australia.

DESCRIPTION OF SERVICES

FinaMetrica provides a psychometric test of personal financial risk tolerance comprising the risk tolerance questionnaire, the demographic questionnaire, the scoring algorithms and the reports ("the Test") to individuals wishing to have an assessment made of their financial risk tolerance. The Test statistically compares your risk tolerance answers with the answers of a sample population of clients of financial advisors. The Test was designed to provide financial advisors with an objective starting point for discussions that will lead to a mutually agreed assessment of a client's financial risk tolerance. This assessment will, in effect, constitute your instructions to the advisor about the level of risk you would normally choose to take. FinaMetrica does not guarantee or represent that the Test assesses your current state of mind or will predict your future state of mind or behavior.

The Website PROVIDES access to and use of the Test.

This agreement including the FinaMetrica Privacy Policy below ("Agreement") between you and FinaMetrica sets forth the terms and conditions governing your (also referred to as "you") access to and use of this Website and the Test.

Your access to and use of this Website and the Test will indicate that you have read and understand this Agreement and accept its terms and conditions. DO NOT PROCEED TO ACCESS AND USE THE TEST UNTIL YOU HAVE CAREFULLY READ THE FOLLOWING. If you accept this Agreement, including all of its terms and conditions, please click on the "Accept" button. You may also wish to print and/or save a copy of this Agreement for your records. If you do not accept this Agreement, you will not be able to access and use the Test.

INTELLECTUAL PROPERTY

FinaMetrica is the owner or licensee of all the intellectual property rights in the materials, data and processes in the Test including without limitation all text, algorithms, content, source and object codes.

The Test is licensed, not sold. This Agreement only gives you some rights to access and use the Test. FinaMetrica reserves all other rights. In consideration of your acceptance of this Agreement, FinaMetrica grants to you a non-exclusive, non-transferable, non-assignable, terminable licence to use the Website to access and use the Test subject to the terms and conditions in this Agreement.

The Test also contains trade secrets of FinaMetrica, and you may not reverse engineer, decompile, decode, decrypt, disassemble the whole or any part of FinaMetrica's intellectual property rights or directly or indirectly allow or cause a third party to reverse engineer, decompile, decode, decrypt or disassemble the whole or any part of FinaMetrica's intellectual property rights except to the extent otherwise authorised by applicable law.

You may not modify, adapt, translate, rent, sublicense, assign, loan, resell for profit, distribute or network the Test or related materials, or create derivative works based upon the Test or any part thereof. ACCESS TO TEST

In order to use the Test, you will require the necessary software, hardware and connection to the World Wide Web (WWW). You are responsible for installing, maintaining, and operating your software and hardware, and the associated WWW connections. FinaMetrica is not responsible for any problems caused to your software or hardware, including any virus or related problems associated with your use of the Test on your equipment. You agree at all times during the continuance of this Agreement to maintain and use appropriate virus-protection software on your equipment used to access our Website and the Test.

FinaMetrica does not guarantee that the Test will always be available or be uninterrupted. FinaMetrica accepts no liability for any failure to comply with this Agreement where such failure is due to circumstances beyond FinaMetrica's reasonable control.

You will need a username and password ("Logon") to access and use the Test. You agree to keep your Logon confidential to prevent unauthorized access to and use of the Test. Your Logon allows only a single risk tolerance test to be completed however you may use it subsequently to view your completed risk tolerance questionnaire and your risk tolerance report for a period of 12 months from the date you completed the risk tolerance questionnaire.

If you have received a Logon as a result of your financial advisor being licensed to use the Website and your advisor's licence to use the Website is terminated for any reason, you understand and agree that your licence to use the Website to access and use the Test will also be terminated.

MODIFICATION, SUSPENSION OR TERMINATION

FinaMetrica may, in its sole discretion, immediately issue a warning, temporarily suspend, indefinitely suspend or terminate your access to the Test, in whole or in part, until further notice, with immediate effect:

- a. to periodically maintain or improve the Test;
- b. if we are unable to verify or authenticate any information you provide to us;
- c. if we believe that your actions may cause legal liability for you, our users or us;
- d. to comply with any order, instruction or request of any government, or other competent judicial, administrative, or regulatory authority; or
- e. if we believe that you are responsible for the unauthorized access of the Test or any infringement of FinaMetrica's Intellectual Property Rights.

FinaMetrica will endeavour, where possible to provide you with reasonable notice of such suspension or termination.

Whilst FinaMetrica will use its best endeavours to minimise disruption to the Test, unscheduled outages may occur from time to time.

FinaMetrica may, in its sole and absolute discretion, immediately terminate this Agreement and your licence to use the Test, without notice or liability, if we determine, acting reasonably, that:

- you have breached a term of this Agreement, and that breach is not remedied within thirty (30) days of you receiving a notice which requests that the breach be remedied; or
- your use of or access to the Test violates any applicable law or regulation or otherwise inhibits any other subscriber from using or accessing the Test or any other service offered by FinaMetrica on the Website.



You agree that upon termination FinaMetrica may, but is not required to, delete all information related to your account and may bar your access to your account and the Test.

On termination of this Agreement for any reason, you must cease using FinaMetrica's intellectual property rights and must cease and prevent any access to the Test using your username and password.
